

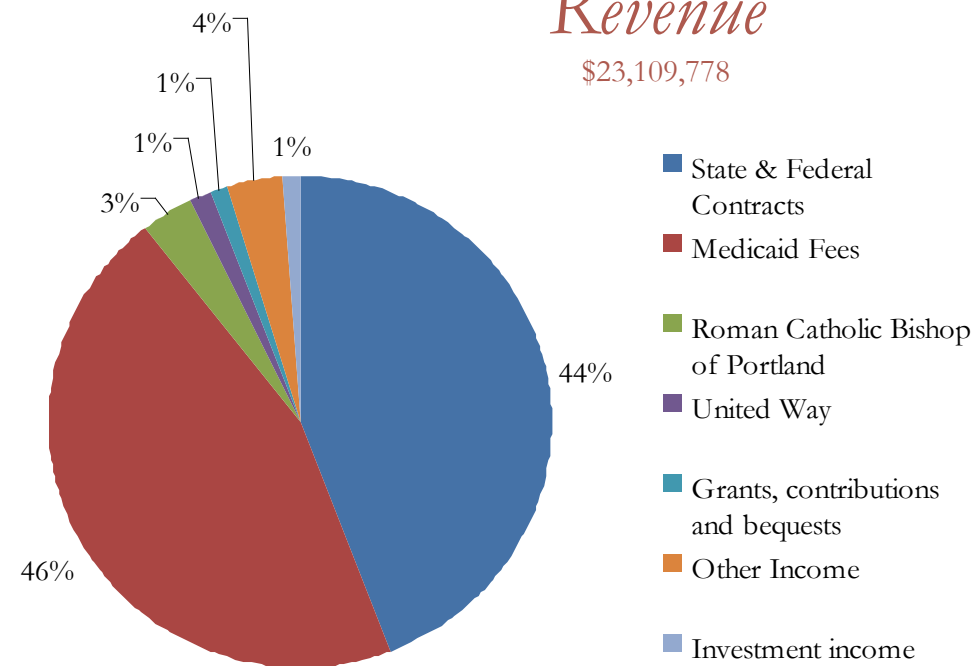

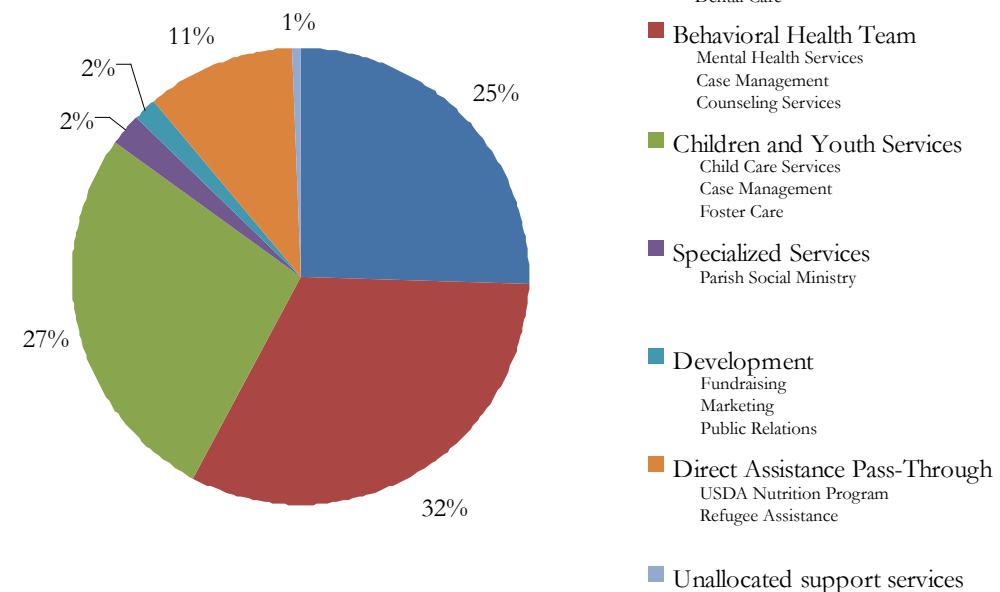

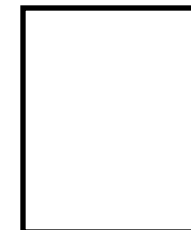

2008 Agency Highlights

- * 43 Victims of Hurricane Katrina that relocated to Maine were assisted through a Social Service Block Grant.
- * St. Joseph's Child Development Center was chosen to participate in a project to promote, sustain and restore children's social, mental and behavior health.
- * The Bishop Amedee Proulx Award for Volunteerism was awarded to Bob Raymond of Augusta.

- * Home Supplies and Food Bank in Aroostook County came to the aid of flood victims by delivering food, water, hygiene kits and supplies to many of the towns impacted by the flood.
- * St. Francis House celebrated Recovery Month by holding the 2nd Annual Walk for Recovery.
- * The 6th Annual Catholic Charities Maine Golf Classic was a success in raising money for St. Louis Child Development Center.

- 493** Elderly and disabled individuals received independent living services.
- 322** Blind and visually impaired children received the resources and services they needed to succeed.
- 345** Children received developmentally appropriate quality childcare and education.
- 3,982** Children and young adults received quality dental care at our dental center in Bath.
- 13** Foster children with emotional and behavioral difficulties were placed in supportive foster homes.
- 238** Children with mental illness, mental retardation, and developmental disorders received case management services.

1,237 Adults with mental illness received case management services.

430 At-risk youths and their families received intervention and support to prevent them from further involvement with the legal or mental health system.

6,464 Children were provided with nutritious meals and snacks by their child care providers through the USDA Food Program.

21,460 Low income families were provided with low cost building materials and food assistance.

1,594 Refugees found help in their resettlement with housing, jobs, and referrals to appropriate services.

3,241 Individuals and businesses statewide received interpreter and translation services.

1,335 Individuals were provided with support for an unplanned pregnancy, post-abortion grief, the pain of being divorced or separated, marriage preparation/enrichment, or fertility care services.

503 Adults received job coaching, job referral, and support.

569 Individuals and families experiencing trouble with drugs or alcohol received counseling services.

188 Men were provided with safe housing and support while they made the transition to a sober life.

270 Individuals were provided with access to counselors who integrate faith into their work.
